EFFECTIVE OCTOBER 16, 2009**

Within 7 days after the issuance of a notice of violation, any person charged with any traffic offense which is eligible for disposition at the Violation Bureau, may appear in person at said bureau with his operator's license and, upon signing a plea of guilty and waiver of trial, and pay the fine established.

NON-WAIVERABLE OFFENSES

- 1) Indictable offenses
- 2) Offenses resulting in a serious ACCIDENT
- 3) Operation of a motor vehicle while Under the Influence of Intoxicating Liquor, Narcotic or habit producing drug, or permitting another person, who is under the Influence of Intoxicating Liquor, Narcotic or habit producing drug to Operate a Motor Vehicle owned by the defendant or in his custody or control.
- 4) Reckless driving
- 5) Leaving the scene of an ACCIDENT
- 6) Driving while Under Suspension or Revocation of Driver's License
- 7) Driving without being licensed to drive
- 8) Exceeding the speed limit by MORE THAN 20 MILES PER HOUR
- 9) A THIRD MOVING traffic offense WITHIN A TWELVE MONTH PERIOD
- 10) Failure to stop and remain standing still upon meeting or over-taking a School Bus stopped on the highway for the purpose of receiving or discharging a school child
- 11) Any violation otherwise eligible for processing by the Traffic Violations Bureau in connection with which the officer, by reason of unusual circumstances, marked the notice as "PERSONAL APPEARANCE REQUIRED"
- 12) Any violation not specifically stated above as waiverable
