BY PAYING A WAIVER, YOU ARE ENTERING A PLEA OF GUILTY.

NON-WAIVERABLE TRAFFIC OFFENSES

- 1) Indictable offenses.
- 2) Operation of a motor vehicle while Under the Influence of Intoxicating Liquor, Narcotic or habit producing drug, or permitting another person, who is under the Influence of Intoxicating Liquor, Narcotic or habit producing drug to operate a Motor Vehicle owned by the defendant or in his custody or control.
- 3) Driving while Under Suspension or Revocation of Driver's License.
- 4) Driving without being licensed to drive.
- 5) Failure to stop and remain standing still upon meeting or over-taking a School Bus stopped on the highway for the purpose of receiving or discharging a school child.
- 6) Any violation otherwise eligible for processing by the Traffic Violations Bureau in connection with which the officer, by reason of unusual circumstances, marked the notice as "PERSONAL APPEARANCE REQUIRED".






